- Whereas, the AICTE is a statutory body established by AICTE Act, 1987. The said Act "provides for establishment of an All India Council for Technical Education with a view to the proper planning and co-ordinate development of the technical education system throughout the country, the promotion of qualitative improvement of such education in relation to planned quantitative growth and the regulation of proper maintenance of norms and standards in the technical education system and for matters connected therewith."
- Whereas, Section 10 of the AICTE Act prescribes the function of the Council and mandates that it shall be the duty of the Council to take all necessary steps and it may think fit for ensuring coordinated and integrated development of technical education and maintenance of standards. Further, Section 10 (k) of the AICTE Act, empowers the AICTE to grant approval for starting new Technical Institutions and for introduction of new courses or programmes in consultation with the agencies concerned.
- 3. Whereas, in order to discharge its duties in accordance with the provisions contained in the AICTE Act the AICTE has framed the regulations for grant of approval for starting new Technical Intuitions, introduction of courses or programmes and increase / variation of intake capacity of seats for the courses or programmes of existing Technical Institutions. The AICTE has also evolved a Handbook for approval process which details out the procedure as well as minimum conditions which an Institute must fulfill in order to seek approval for either starting new Technical Institutions or for introduction of courses / programmes as increase / variation of intake capacity of seat for courses / programmes as well as existing Technical Institute.
- Whereas, Azad Institute of Pharmacy & Research, Lucknow, U.P. had applied Under Chapter-II for introduction of a new Pharmacy course at Diploma Level.
- 5. Whereas, the Council conducted a surprise visit to the Institute on 17/03/2017, which brought out various deficiencies with regard to building / built-up / instructional/administrative/amenities area/ faculty or anti- ragging etc.
- 6. Whereas, the case was placed before the SHC held on 02-04-2017 but the Institute was **absent** on that day. However, as requested by the Institute, the case was placed before the SHC on 06.04.2017. The Institute attended the SHC. The recommendation of the SHC is as under.

"The Institutes representatives have submitted the documents for removal of deficiencies. Barring short-fall in faculty & availability of language lab, compliance for rest of the deficiencies have been met.
